**AN ORDINANCE AMENDING THE LAND DEVELOPMENT CODE,
ORDINANCE NUMBER 3209, SECTION 7.12.8.3 STANDARDS OF DESIGN, PARKING
REQUIREMENTS, TO READ "7.12.8.3 PAVING. PARKING SHALL BE HARD SURFACE AS
APPROVED BY THE ENGINEERING DEPARTMENT. ADDITIONAL PARKING MAY BE
PAVED WITH PERVIOUS PAVERS/PAVEMENT AS APPROVED BY THE SITE AND
DESIGN REVIEW COMMITTEE."
AND TO AMEND SECTION 7.12.10. STANDARDS OF DESIGN, PARKING REQUIREMENTS,
TO READ "7.12.10 SECTION RESERVED".**

**BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF
HATTIESBURG, MISSISSIPPI:**

SECTION 1. That the Land Development Code, Ordinance Number 3209, of the City of Hattiesburg, Mississippi, Section 7.12.8.3., Standards of Design, Parking Requirements, be amended to read "7.12.8.3 Paving. Parking shall be hard surface as approved by the Engineering Department. Additional parking may be paved with pervious pavers/pavement as approved by the Site and Design Review Committee."

SECTION 2. That the Land Development Code, Ordinance Number 3209, of the City of Hattiesburg, Mississippi, Section 7.12.10., Standards of Design, Parking Requirements, be amended to read "7.12.10 Section Reserved".

SECTION 3. Except as hereby expressly changed and amended, the aforesaid Land Development Code, Ordinance Number 3209, adopted February 21, 2017, of said City of Hattiesburg, Mississippi, shall be and remain in full force and form as adopted.

SECTION 4. That this Ordinance take effect and be in force thirty (30) days from and after passage as provided by law.
