

#### **INSTRUCTIONS TO APPLY FOR COMMERCIAL PROJECT PERMIT:**

IMPORTANT REMINDER FOR CONTRACTORS: THE FIRST STEP FOR OWNERS: OWNERS MAY NOT BE AWARE THAT THEIR PROJECT MAY REQUIRE APPROVAL FROM THE PLANNING DIVISION. ALL NEW COMMERCIAL BUILDINGS/COMMERCIAL ADDITION OF SQUARE FOOTAGE OR AFTER EXTERIOR CHANGE IN OCCUPANCY USE WILL REQUIRE APPROVAL. IF THEY HAVE NOT DONE SO, THEY SHOULD CALL CITY OF HATTIESBURG PLANNING DEPT. AT 601.545.4599. THE PLANNING DIVISION HAS A COMPLETELY SEPARATE PAPERWORK PROCESS, FEE, AND SCHEDULE.

#### TO FILL OUT PERMIT APPLICATION:

- 1. ALL COMMERCIAL PLANS FOR PROJECTS OF 5,000 SF OR MORE MUST BE STAMPED AND SIGNED BY MS LICENSED ARCHITECT-The seal does not have to be a wet seal, but each page must be signed/stamped.
- 2. IF YOU HAVE ANY SPECIFIC QUESTIONS ABOUT YOUR PLANS, PLEASE CALL THE BUILDING DEPARTMENT BEFORE DRAFTING THEM. 3 ORIGINAL SETS MUST BE SUBMITTED WITH A \$200.00 CHECK MADE PAYABLE TO THE CITY OF HATTIESBURG. THIS IS THE PLAN REVIEW FEE AND IT IS NOT THE PERMIT FEE. (GRADING ONLY: No building plans required, in most cases a site plan will be required.)
- 3. SITE PLAN AFFIDAVIT NEED TO BE SUBMITTED WITH THE APPLICATION. (IF SITE PLAN REVIEW MEETING WAS REQUIRED BY PLANNING) This 2-PAGE document will need to be notarized and submitted with the permit application. THE PLANNING DIVISION WILL GIVE THIS DOCUMENT TO THE OWNER AFTER THE SITE PLAN REVIEW COMMITTEE HAS APPROVED THE PROJECT.
- 4. IF THE PROJECT IS \$50,000 OR LESS, THE OWNER MAY CHOOSE TO PULL THE PERMIT THEMSELVES, HOWEVER, THE SUB-CONTRACTORS FOR ELECTRIC, MECHANICAL, PLUMBING, FIRE SPRINKLER/SECURITY **MUST** BE LICENSED WITH THE CITY OF HATTIESBURG.
- 5. A LICENSE WITH THE CITY OF HATTIESBURG IS NOT THE SAME AS A LICENSE WITH THE STATE. STATE LICENSE MAY TAKE UP TO A MONTH TO COMPLETE. PLEASE CALL THE BUILDING DIVISION TO CONFIRM THAT THE CONTRACTOR IS LICENSED WITH THE CITY.
- AN APPLICATION AND PERMIT FEE SCALE HAVE BEEN ATTACHED. PLEASE CALL IF YOU NEED ASSISTANCE. WE WILL BE HAPPY TO HELP YOU.
- 7. IF YOU ARE MAILING YOUR PERMIT APPLICATIONS/PLANS BY FED EX OR UPS. PLEASE **USE OUR PHYSICAL ADDRESS:**

#### FINAL ADMINSTRATIVE RULE/REGULATION ADOPTION STATE BOARD OF CONTRACTORS STATE OF MISSISSIPPI

Effective October 15, 2007 the following administrative rule/regulation has been officially adopted by the Mississippi State Board of Contractors.

Once a building permit is issued to a residential builder or remodeler, or the holder of a certificate of responsibility by a municipal or county building official, or any other authority charged with the duty of issuing local building permits, such licensed residential builder or residential remodeler or holder of a certificate of responsibility shall exhibit a sign at the permitted job site which shall include, prominently displayed in lettering at least two (2) inches high and twelve (12) inches wide, the license or certificate of responsibility number of the residential builder or residential remodeler or holder of the certificate of responsibility and the State issuing it.

The following permit fee schedule will be used to calculate all other types of permit/inspections for new, expansion or renovation construction for residential\* and/or commercial work, demolitions, land disturbance (including grading, grubbing, and/or clearing) signs, and said fees shall be made prior to issuance of permit:

\$1 to 500.00	\$24.00
\$500.01 to \$2,000	\$24.00 for the first \$500, plus \$3.00 for each additional hundred or fraction thereof
\$2,000.01 to \$40,000	\$69.00 for the first \$2,000 plus \$11.00 for each additional thousand or fraction thereof
\$40,000.01 to \$100,000	\$487.00 for the first \$40,000 plus \$9.00 for each additional thousand or fraction thereof
\$100,000.01 to \$500,000	\$1,027 for the first \$100,000 plus \$7.00 for each additional thousand or fraction thereof
\$500,000.01 to \$1,000,000,.00	\$3,827 for the first \$500,000 plus \$5.00 for each additional thousand or fraction thereof
\$1,000,000.01 to \$5,000,000.00	\$6,327 for the first \$1,000,000 plus \$3.00 for each additional thousand or fraction thereof
\$5,000,000.01 and over	\$18,327 for the first \$5,000,000 plus \$1.00 for each additional thousand or fraction thereof

Additional information, or inspection trips, made necessary through the failure of a contractor to specify location of installation, or failure to install equipment properly, or to otherwise create conditions making such additional inspections or trips necessary, are hereby designated "Re-Inspections." For each such "Re-Inspections," the designated Re-Inspect Fee shall be charged against and paid by said contractor into the treasury of the City of Hattiesburg.

Permit fees shall apply to all owners, contractors, and non-profit organizations, with the only exception being those non-profit organizations (with approved non-profit charters) providing construction services on a totally volunteer basis for new, expansion or renovation construction on single-family residences.
