The TIP amendment defines Federal aid projects for the HPFL- MPO.

An application was received from a member of the Hattiesburg-Petal- Forrest-Lamar Metropolitan Planning Organization (HPFL-MPO). The proposed application was considered first by the HPFL-MPO Technical Committee on October 9, 2019 and will be decided by the HPFL-MPO Policy Committee at its October 23, 2019 meeting. The meeting is scheduled for 10:00 a.m. at the Intermodal Facility (Historic Train Depot), Community Room, 308 Newman Street, Hattiesburg, MS. The meeting includes an opportunity for public comment in person. Following are general details on the application received.

This notice serves to notify the public that the HPFL-MPO Committees will consider a TIP amendment and will include changes to projects already listed on the TIP.

Project Amendment:

- Consider to move Classic Drive Project TIP Project #502 to FY 2022, reduce Federal funds allocated to the project by \$295,000, and increase local fund or other funding commitments by \$295,000.
- Amend funding to accommodate the J Ed Turner Project TIP #503 (107039) by increasing Federal funds (STP) by an additional \$295,000.

This process is being conducted in accordance with the 2019-2022 Transportation Improvement Plan (TIP).

In compliance with federal regulations 23CFR 450 and according to the MPO Public Participation Plan (PPP), any amendments to the TIP requires a minimum of a ten (10) day public comment period. The proposed amendments to the TIP will be available for review from *Thursday, October 17, 2019* through *Monday, October 28, 2019* at the MPO office located at 308 Newman St., Hattiesburg, MS 39401.
